Section 4: First Aid Measures

General Info: Ensure proper ventilation.

Notable Exposure symptoms: Irritation to skin, eyes and areas of contact.

If ingested: Rinse mouth. Seek immediate medical attention. Clear the airway and administer artificial respiration if not breathing.
If swallowed, do not induce vomiting unless directed to do so by medical personnel.

Other Precautions: 0.01 ppm high efficiency particulate respirator/supplied air respirator/self-contained breathing apparatus; 0.2 ppm same as above with full face piece; 1 ppm powdered air purifying respirator with high efficiency filter/type C supplied air respirator operated in pressure demand mode. Store in a sealed container, plastic or plastic liner, in a cool, well ventilated, dry area away from volatile acids.

Recommendations for Storage: Store in cool, dry area in a tightly closed product container under nitrogen away from sources of ignition or flame and volatile acids. Do not store directly on ground.
