Section 4: First Aid Measures

General Info: Consult a Physician. Show this safety data sheet to the doctor in attendance.

Notable Exposure symptoms: Irritation to skin, eyes and areas of contact.

If ingested: Rinse mouth. Seek immediate medical attention. Clear the airway and administer artificial respiration if not breathing.

If swallowed, do not induce vomiting unless directed to do so by medical personnel.

Section 6: 6. Accidental Release Measures

Personal precautions, protective equipment and procedures: Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Wear appropriate respiratory protective equipment and clothing during clean-up. Avoid breathing dust. Ventilate area if easy to do so. Contact local authorities if significant spillages cannot be contained. For personal protection, see section 8 of the SDS.

Containment Equipment and Procedures: Large Spills: Contain actively spilling material if safe and easy to do so. Do not let product enter drains. Sweep or soak up and place in sealed container for reclamation or disposal, taking care to avoid dusting. Ventilate area and wash spill site after pick-up is complete.

Small Spills: Sweep or soak up and place in sealed container. Taking care to avoid dusting.

Cleanup Procedures: Contain spillage and then collect with an electrically protected vacuum cleaner or by wet brushing and place in container for disposal according to local regulations.
